- (1) Cover letter explaining why you are applying for a scholarship and how will it be used;
- (2) If you are attending college for the first time-Original High School transcripts showing your completion date and final GPA **OR** Original College Transcripts from the last trade/technical school or college you attended. Please provide your most current transcript for a period of at least one year. To qualify for a Foundation Scholarship you must have at least be awarded a standard high school diploma or passed the GED (if you passed the GED then provide a copy of that in place of the high school transcripts with date of graduation);
- (3) Two letters of recommendation from anyone other than your immediate family members;
- (4) Completion of the current year FAFSA application;
- (5) Any other supporting information that you wish to submit for consideration, may also be attached.

Applicants are responsible for turning in all requested information (including transcripts) with their application.

Any application that is not complete in its entirety, including all required attachments, will be disqualified for submitting an incomplete application, and will not be eligible for an award.

FOUNDATION’S WITHDRAWAL POLICY WITH REGARDS TO FUTURE SCHOLARSHIPS:

- If a student withdraws from a class with penalty, then the student must pay the penalty through the Business Office.**
- If a student withdraws from class going from a full-time status to a part-time status, then there will be a reduction in available scholarship dollars for the following semester.**
- If a student drops all classes to receive no credit hours, a written explanation must be provided in order to apply for future scholarships.**
- All scholarship decisions are at the discretion of the Scholarship Committee and/or Executive Director of the Foundation.**
